**AND IS SUPPLEMENTAL TO** a deed of declaration of trust made by PML (formerly Homeloans Direct Limited) on 13 May 1994 as supplemented and amended, inter alia, by:

- (vii) a seventh supplemental deed of declaration of trust dated 30 September, 1998;
- (viii) an eighth supplemental deed of declaration of trust dated 21 January, 1999;
- (ix) a ninth supplemental deed of declaration of trust dated 11 June, 1999;
- (x) a tenth supplemental deed of declaration of trust dated 29 February, 2000;
- (xi) an eleventh supplemental deed of declaration of trust dated 29 February, 2000;

- (xiv) a supplemental deed of declaration of trust dated 27th March, 2002;

(together hereinafter called the "Declaration of Trust").

## WHEREAS:

- (A) PML is acting as an originator and a seller in respect of a further securitisation, which is to close on the date hereof, in respect of which the issuer of the notes being issued and purchaser of certain mortgages being sold by PML in respect of the further securitisation is Paragon Mortgages (No.15) PLC (the "Issuer") and Paragon Finance PLC ("PFPLC") and Mortgage Trust Services plc ("MTS") have agreed to act as the administrators for the same.
- (B) PML is desirous of extending the benefit of the trust declared in the Declaration of Trust to the Issuer in respect of the mortgages to be purchased by the Issuer.

#### NOW THIS DEED WITNESSETH as follows:

#### 1. **INTERPRETATION**

- 1.1 Unless otherwise defined herein, terms defined in the Declaration of Trust shall have the same meaning when used herein (including in the recitals).
- 1.2 The headings are inserted for convenience only and shall not affect the interpretation of this Deed.
- 1.3 Words denoting the singular number only shall include the plural number also and vice versa; and "persons" shall include individuals, firms and corporations.
- 1.4 References in this Deed to any agreement or other document include any amendment thereto or variation or novation thereof for the time being having effect.

#### 2. THE TRUST

PML hereby acknowledges, declares and agrees that from the date hereof:

- (a) the Issuer shall hereby be appointed as a Beneficiary under the Declaration of Trust;
- (b) in accordance with the terms of the Declaration of Trust, at any time such proportion of the Total Property at such time as the amounts derived from the Assets of the Issuer and standing to the credit of the Account shall at such time

bear to the Total Property at such time, shall, in relation to the Issuer, be its Beneficiary's Share; and

(c) the provisions of the Declaration of Trust and the trust declared therein shall apply to the Issuer as they apply to the other Beneficiaries.

# 3. DESIGNATION AS SECURITY TRUSTEE

PML hereby designates Citicorp Trustee Company Limited acting through its principal London office at Citigroup Centre, 14th Floor, Canada Square, Canary Wharf, London E14 5LB, as trustee in respect of any security given by the Issuer for its obligations under a deed of sub-charge and assignment to be dated the date hereof between, among others, the Issuer, Citicorp Trustee Company Limited, PFPLC, PML, MTS, Mortgage Trust Limited and Homeloan Management Limited.
